Gospel Funding Program Agreement

Revised 3/23/11

1. Purpose: To financially assist legitimate 501(c)3 ministries, Christian organizations and institutions in spreading the Gospel around the world.

2. Means: **Max Greiner, Jr. Designs** (the company) will donate to participating organizations and missionaries, (on an individual or organizational basis), a monthly financial gift of 10% of the purchase price of any Greiner artwork sold by **Max Greiner, Jr. Designs**, which was directly facilitated by the participating organization, as described in this document.

3. Method: Participating organizations, at their discretion, agree to recommend, present and make known to their supporters, the artwork and Christian testimony of Max Greiner, Jr. This presentation can be on television, radio, internet websites, E-Blasts, literature and in person. The purpose of the program should be explained to supporters, but it does not need to be "sold." The Holy Spirit will bring in the "financial" harvest, if it is His will, without the need for "hard", or manipulative selling.

4. Ministry Gift Program: **Max Greiner, Jr. Designs** currently allows any 501(c)3 ministry or charitable organization to purchase Greiner artwork at a special 15% discount. Greiner artwork may be purchased by participating ministries at the discounted price for decoration, as donor gifts, to sell, or as show samples. It is recommended that actual examples of Greiner's Christian artwork be available for display or presentation. NOTE: Purchases made by participating organizations at the discounted price do not qualify for the 10% monthly gift donation, since a discount has already been given.

5. Art Image Use Program: **Max Greiner, Jr. Designs** will allow 501(c)3 organizations the free use of copyrighted Greiner art images, and trademarked names and logos, under special conditions. This "Intellectual Property" can be used on websites, E-Blasts, literature, during presentations, services and conferences, if the organization agrees in writing, to abide by the artist's "Terms of Use" requirements, regarding copyright and trademark protection.

6. Promotion: Participating organizations should use Greiner artwork images to decorate their literature, emails, websites, TV and radio shows to share the Gospel and communicate their own mission. This **Gospel Funding Program** should also be explained when donations are discussed.

SAMPLE - Statement:

Ministry Partners: Artist, Max Greiner, Jr. and his wife are committed Christians who support this ministry. They have graciously offered to make donations to us if their customers ask. Therefore, when placing an order at the **Max Greiner, Jr. Designs** website (www.maxgreinerart.com) simply place a check in the box next to our ministry name so we can receive a 10% donation. Orders can also called in to: (800) 637-9651.

Please state that you would like to support this ministry at the time your purchase is made.

SAMPLE - Recorded 60 Second PSA “Biblical Giving” Script:

1. I am artist/evangelist, Max Greiner, Jr.
2. My wife and I want to encourage you to be a “Giver”!
3. The Bible says to tithe to your church, help the needy, and support the work of the ministry!
4. You probably don’t know me, but you may know my artwork.
5. It’s in homes, offices, churches, colleges and seminaries around the world.
6. By the grace of God, my art is in the collections of Popes, Preachers, Presidents, Governors, international business leaders, and the stars of sports, music, movies and TV.
7. I am the artist who created the “*Divine Servant*” back in 1989.
8. My other Christian art includes the “*Christian Butterfly*”, “*Fisher of Men*”, “*The Great Commission*”, “*The Coming King*”, “*The Empty Cross*” and the “*Lion of Judah*”.
9. Would you help us support this worthy ministry, which is touching lives for Jesus?
10. Our company, **Max Greiner, Jr. Designs** of Kerrville, Texas, will make a 10% donation, when you buy my art!
11. So, the next time you make a purchase, just tell us to make a donation to this ministry!
12. Thanks again for helping us build the “Kingdom of God”!

Max Greiner, Jr. Designs will also share, showcase and promote the work of participating ministries on its own website and literature and whenever appropriate. Links to, and a description of participating ministries will be included on the Greiner website.

7. Orders: All customers must make their purchases directly with **Max Greiner, Jr. Designs**. This can be done in person, by mail, email, fax, telephone or internet at the Greiner website. Customers must request that the donation be made to the ministry at the time the order is placed, for the ministry to be credited 10%.

8. Greiner Donations to Ministries: Participating organizations or missionaries (either individually or corporately) will be issued a gift donation check at the beginning of each month, following a sale. Gifts amounting to less than \$100.00 in any given month will be accrued to the next month, until this amount is exceeded. The amount given to the ministry will be 10% of any and all sales. (However, this will not include any discounted purchases by the ministry itself.)

The monthly Greiner donation is a voluntary gift donation, and is not a “sales commission.” However, the size of this monthly gift will be based on the sales price of the artwork, not including sales tax, or shipping. The gift donation will **ONLY BE PAID** if a customer specifically requests that the donation be made to the participating ministry, **AT THE TIME THE ORDER IS PLACED** with **Max Greiner, Jr. Designs**. No gifts will be distributed to the ministry until the order has been “paid in full” by the customer.

9. Product Delivery: Most Greiner art products priced less than \$1,000 are usually in stock and can be shipped within 48 hours. Large quantity orders, and orders for large bronze sculptures may require 3 to 4 months for production. Shipments out of the country will be considered on a case-by-case basis.

10. Terms & Expiration: Prices and available art product are determined by **Max Greiner, Jr. Designs** and are subject to change without notice. This program can be modified or terminated at any time by **Max Greiner, Jr. Designs**. This Agreement automatically expires one year after signing, unless both parties renew it in writing, during the final month of this Agreement. Either party can terminate this Agreement, at any time for any reason, with a 10-day advance notice, made in writing. Gift donations will be paid on all sales transactions occurring prior to the Agreement termination.

It is understood by each party that this special program was created to help fund the advancement of the Kingdom of God, and the Gospel of Jesus Christ.
